- * The pruning shall be carried out under the supervision of competent official of the concerned horticulture department to ensure that no exploitative pruning occurs in violation of this order and provision of DPTA, 1994.
- * It has also been noticed during inspection that the root area around the trees has been cemented. It is therefore directed that an area of 6X6 fit around each tree has to be de-concretized immediately, keeping in view directions of the Hon'ble NGT in the matter of O.A. No. 82/2013, titled Aditya N. Prasad Vs Govt. of NCT of Delhi & Ors.

Terms & Conditions:

- 1. Permission to prune/pollard the tree/s is granted at the risk of the applicant and without prejudice to the claims of any other person/s who may be having any rights over the land of the tree/s.
- 2. If any tree/branch is found to have nest of birds it should not be pruned/cut till the same is abandoned by the birds.
- 3. Pruning/pollarding of tree/s shall be completed within 30 days. In the event that the pruning is not carried out within the said period, the permission shall be treated as lapsed and would require fresh request as per DPTA, 1994.
- 4. Material produced from pruning/pollarding of tree/s shall not be removed or disposed without transport permission issued by Tree Officer.
- 5. The applicant shall ensure that pruning/pollarding does not result in death of the tree. In case of death of any tree resulting from improper pruning/pollarding, Tree Officer shall cause ten times the number of dead trees to be planted in the area and recover the cost of such plantation and maintenance till the time of the establishment of the tree from the applicant in accordance with Law.
- He will also ensure the compliance of all other laws, rules, orders, and orders of the courts and master plan of Delhi, if any applicable in the
- The landowning agencies shall ensure that wood/lops/tops arising out the pruning should find its way only the MCD crematoria in Delhi in greater public interest or as per policy of agency as decided by the Secretary/HOD/Competent Authority.
- After the pruning is done photographs of pruned trees be submitted to Tree Officer's office.
- The applicant shall liaise with concerned land owing agencies and carryout the work with them consent only. Any litigation shall be the sole responsibility of the applicant as permission is being awarded keeping in view the possible safety hazard.
- 10. A report, post pruning to be submitted by CPWD/PWD/MCD/DDA along with signatures of RWA members/residents of the area indicating the status of the work carried out.
